- 3. In compliance with the provisions of section 108 of the Act read with the Companies (Management and Administration) Rules, 2014 and any amendments thereto and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations') as amended from time to time, the Members are informed that the Company is offering 'e-voting' facility as an alternative mode of voting which will enable the members to cast their votes electronically. The e-voting period commences from 9.00 a.m. (IST) Monday, 11th February, 2019 to 5.00 p.m. (IST) Tuesday, 12th March, 2019. During this period, Members holding shares either in physical form or in dematerialized form, as on 1st February 2019 i.e. Cut-off date, may cast their vote electronically.
- 7. This form must be completed and signed by the Member. In case of joint holding, this form must be completed and signed (as per specimen signatures registered with the Company/ Depository Participant) by the first named Member and in his absence, by the next named joint holder. A Power of attorney (PoA) may vote on behalf of a Member, enclosing a copy of a PoA duly attested by the Notary Public.
- 8. Institutional Members are required to send a scanned copy of relevant Board Resolution / Power of Attorney together with attested specimen signature of the duly authorized signatory/ies who are authorized to vote, to the scrutinizer at shawati.vaishnav@gmail.com with a copy marked to evoting@nsdl.co.in.
- 9. In case of shares held by Companies, Trusts, Societies, etc, the duly completed Postal Ballot Form should be accompanied by a certified copy of the Board Resolution together with the specimen signature(s) of the duly authorized signatories.
- 10. The Postal ballot shall not be exercised by a proxy.
- 11. Voting rights shall be reckoned on the paid up capital of the shares registered in the name of the member as on cut off date i.e. 1st February 2019.
- 12. There will be one Postal Ballot Form for every folio/ DP Id and Client Id irrespective of number of joint holders.
